GENERAL INFORMATION

Students are invited to submit audition recordings in order to be considered for the All-State Jazz Band. The All-State Jazz Band festival is held in conjunction with the Alabama Music Educators Association In-Service Conference at the Birmingham Jefferson Civic Complex (BJCC) from January 16-18, 2025. Selection for the Alabama All-State Jazz Bands is determined by a recorded audition that students prepare. Director should send recordings and payment to the ABA Jazz Education Division as listed below. A qualified panel of adjudicators will be judging student recordings. Band directors will then be notified of the selected students approximately three weeks after the deadline. Directors must be members of NAfME in order for their students to audition and participate in the All-State Jazz Bands.

AUDITION PROCEDURES AND INFORMATION

Students in 9th-12th grades audition for the High School Jazz Bands. Students in 8th grade and below will audition for the Middle School Jazz Band (they may choose to audition at the high school level with director approval). The third-year provision is in effect for All State Jazz Band auditions. This means 9th graders in their third year of study may audition for the middle school band.

Directors must complete the online All State Jazz Registration and mail fees to Nick McDonald at the address listed below in order for students to audition. Online registration and payment must be received by November 1, 2024. Please be careful with the spelling of student names as this data will be used throughout the audition and concert process. An invoice will be emailed to you upon completion of the online registration. Please login to alaband.org for more information.

Once the director has registered students online and registration payment has been received by the Jazz Education Chair, they will receive a Google Drive link to upload their students' recordings to their school's audition folder. No CDs will be accepted for auditions.

PAYMENT INFORMATION

By November 1, 2024, band directors should mail one registration fee check, made payable to the ABA Jazz Education Chair at the following address:

The audition fee is \$15.00 per student along with the school fee of \$20.00 per school. After completing the registration form, a receipt will be sent to the director. Directors should send the total amount from the invoice as one (1) check to the ABA Jazz Education Chairman. These fees must be postmarked no later than November 1, 2024.

Students who are chosen for the All-State Jazz Bands will be informed December 6, 2024. A \$50.00 per student registration/participation fee must be sent to the ABA Jazz Education Chair before they can attend the event. Directors of accepted students should inform the ABA Jazz Education Chair of their decision by **December 9, 2024** to receive practice music files for their students or allow time to invite alternates to attend the event.

RECORDING PROCEDURES

- Once the director has registered students online, the Jazz Chair will send a Google Drive link to upload registered students' recordings to their school's audition folder.
- No CDs will be accepted for auditions.
- All audition recordings should be in high quality mp3 format (NOT .m4a, wav, .mov, .aiff, etc).
- Auditions should be recorded live with no special editing or effects.
- Neither students nor directors should speak or introduce themselves on the recordings.
- Each student's recording should be submitted as ONE mp3 file, labeled as follows.

Instrument FirstName LastName

Examples: AltoSax John Doe Piano Maria Garcia Trumpet Sally Jones

• You can combine your mp3 recordings into one file with software such as Audacity (download for free at audacityteam.org) or Garage Band. Recordings containing multiple tracks will be returned to the director. Be sure you send recordings with ONE track that includes ALL of the student's audition requirements.

The order of items on the recording for wind players, guitar, bass, vibraphone, and piano should be:

- Scales (played in the order listed)
- Etude
- Play-A-Long tunes (played in the order listed)

The order of items on the recording for drum set players should be:

- Patterns (played in the order listed)
- Etude
- Play-A-Long tunes (played in the order listed)

Once recordings are completed, submit all recordings to the Google Drive folder created by the Jazz Education Division. The school folder will be sent to the director after they have registered students using the email provided in the registration.

Google Drive school folders will be sent out no later than December 9, 2024.

Play-a-Long Backtracks

Audition backtracks have been added to the 'member's only' section of the alaband.org website to make sure students move from one play-a-long to the next more easily. Please review each individual instrument's audition procedures to ensure students perform with the correct track.

AUDITION CHECKLIST FOR DIRECTORS

- Download individual audition information from the <u>alaband.org</u> and purchase any books from your local music dealer or from the sources listed on the individual instrument audition files.
- Be sure your students, private instructors, and parents have all needed materials and information. Complete the All State Jazz Band Audition Registration form by 11:59 PM on November 1, 2024. Have ONE Registration Payment covering all student and school fees postmarked no later than November 1, 2024
- Review the Recording Procedures in this document.
