CHANGES TO LEGISLATION

- Small changes to middle school scale requirements. Check audition requirements.
- All-State fees - retired directors can attend without a fee. Additional directors or directors without students will not have to pay an additional school fee (\$40 instead of $\$50 + \$40 = \$90$)
